Monthly Meeting of the Covington Town Board
April 10, 2012

The monthly meeting of Covington Town Board was held on Tuesday April 10, 2012 at the Covington Town Hall. Present were Councilpersons Paul Tobias, Larry Warren and Brian Murphy. Also present were Supervisor Jerry Davis, Town Clerk Amy Wiedrich, Zoning Officer Alan Rudgers, Highway Superintendent Mike Bell and resident Karl Smith.

The pledge of allegiance opened the meeting at 7:30 p.m.

On a motion of Councilperson Murphy, seconded by Councilperson Warren the following resolution was
