Monthly Meeting of the Covington Town Board
August 14, 2012

The monthly meeting of the Covington Town Board was held on Tuesday August 14, 2012 at the town building. Present were Councilpersons Paul Tobias, Brian Murphy, Larry Warren and Sharon West. Also present were Supervisor Jerry Davis, Town Clerk Amy Wiedrich, Highway Superintendent Mike Bell and Bookkeeper Deb Long. Town Attorney David Dimatteo, Ed Smart of Smart Design and residents Karl Smith, William Zuber and Jennifer Northrup also attended the meeting.
