The monthly meeting of Covington Town Board was held on Tuesday May 8 at Covington Town Hall. Present were Councilpersons Brian Murphy, Larry Warren, Paul Tobias and Sharon West. Also present were Supervisor Jerry Davis, Town Clerk Amy Wiedrich, Highway Superintendent Mike Bell, Zoning Officer Alan Rudgers and Bookkeeper Deb Long.
